

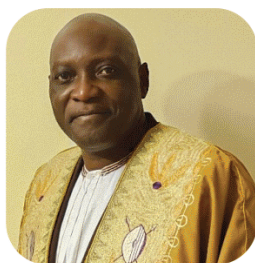

Brief history of Buganda

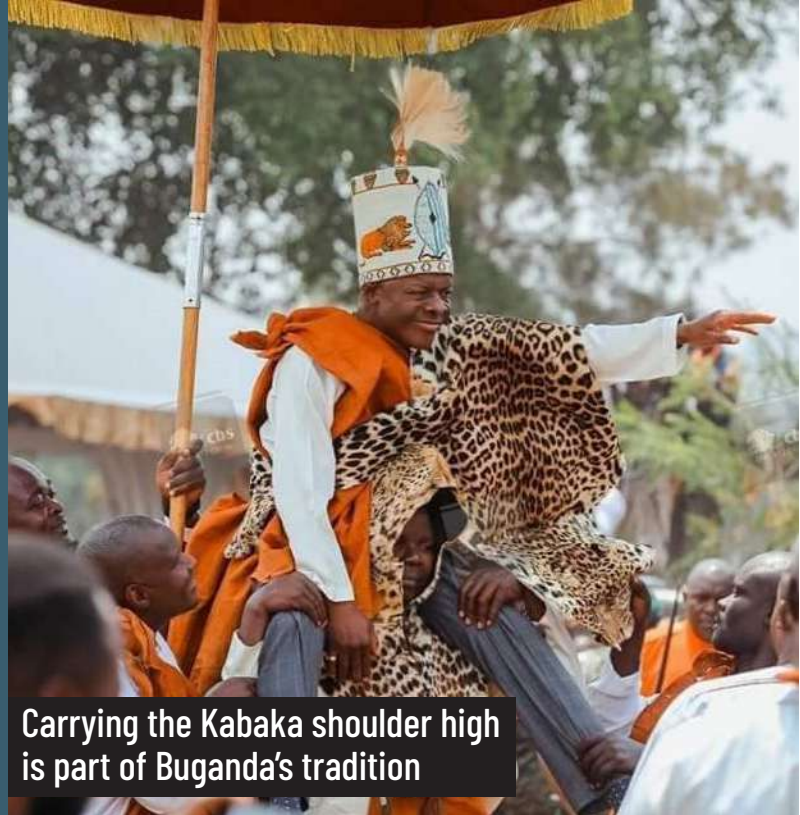
The Kingdom of Buganda, the largest and most influential traditional kingdom in Uganda, traces its roots to the late 14th century. It was founded along the shores of Lake Victoria, with oral traditions attributing its origins to Kabaka Kintu, who united various clans after defeating Bemba Musota. Another theory points to Kato Kimera, a prince from Bunyoro-Kitara, as the founder. Buganda grew from a small nucleus of Busiro, Mawokota, and Kyadondo into a vast kingdom, expanding under powerful monarchs like Kabaka Kateregga, Kabaka Mawanda, and Kabaka Muteesa, often through military strength and political alliances, including cooperation with the British in the 19th century.

As the kingdom evolved, so too did the role of its monarch, the Kabaka from a traditional ruler to a modern custodian of his people's welfare.

In today's context, the Kabaka Foundation serves as the Kabaka's official charitable arm, acting as a bridge between the monarchy and the people. Through this platform, the Kabaka carries out philanthropic, developmental, and humanitarian initiatives in health, education, youth empowerment, culture, and environmental conservation. The Kabaka Foundation is governed by a Board of Trustees chaired by His Majesty the Kabaka of Buganda himself. Its headquarters are located at Bulange Building, Mengo, the traditional and administrative seat of the Buganda Kingdom in Kampala, Uganda.

The Foundation head office, oversees the implementation of programs across all Foundation chapters across the globe. Each chapter functions semi-autonomously with its own local board and leadership, ensuring grassroots engagement and community relevance in every region.

The Foundation embodies the spirit of "Obuntubulamu" - a value deeply rooted in Buganda's heritage; by promoting unity, dignity, and compassion for all.

About Kabaka Foundation

T Kabaka Foundation is a charitable trust governed by a Board of Trustees, chaired by the Kabaka of Buganda. Its vision is “To improve the quality of life in the Buganda region,” and its mission is “To draw on the strengths of the Kabakaship to mobilize and avail resources to charitable projects for sustainable community development in Buganda.”

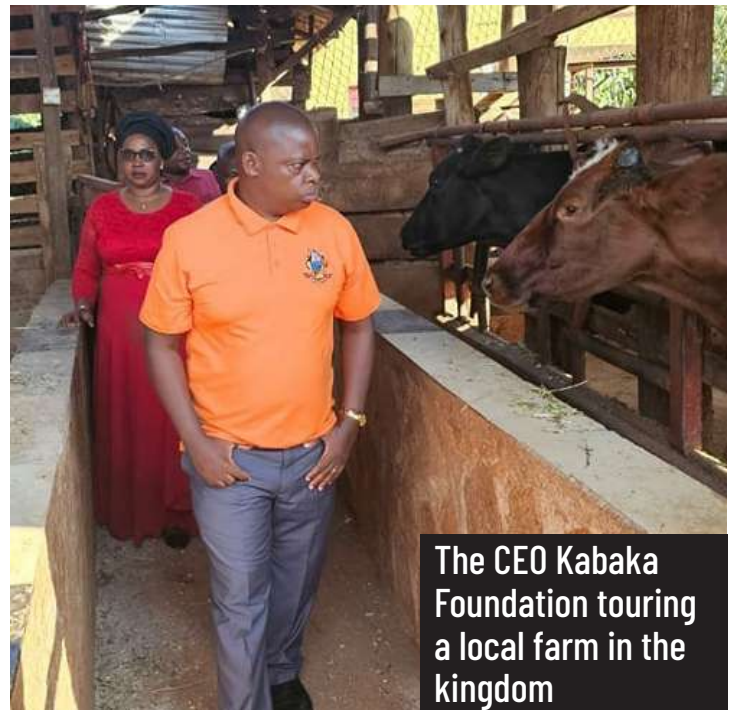
The Foundation focuses on promoting sustainable community development through the following areas: Health, Agriculture, Education (Omugotteko), the Kabaka’s Trail (Cultural Tourism Sites), Philanthropy with clan heads, Agriculture and Environmental Conservation, and Economic Empowerment.

The Kabaka Foundation has 12 chapter branches across the world, located in California, Chicago, Boston, Canada, the UK, Australia, Japan, South Africa, Germany, Sweden, Norway, and Finland. The Foundation’s head office in Kampala, Uganda, oversees and manages these global branches.


Between 2021 and 2023, the Foundation spearheaded a blood donation drive that collected over 23,000 units of blood, ensuring an adequate supply for medical emergencies. The campaign also recruited 104 new blood donors for the Uganda Blood Bank. In 2022, the Foundation received a recognition award from the International Division of America’s Blood Centers in Arizona, USA,

as a Top Global Blood Drive Partner. In 2023, the Foundation was awarded the Henry Dunant Award by the Red Cross in recognition of its significant contribution to national blood collection efforts.

The Foundation has coordinated several health initiatives in the region. These include Hepatitis B vaccination campaigns that reached over 65,000 individuals, significantly reducing the disease's spread. In the area of HIV/AIDS awareness and treatment, outreach efforts reached over 50,000 people between 2021 and 2023, with support services provided to more than 1,000 patients. The Foundation has also engaged with over 20,000 people annually through its tuberculosis (TB) support services, benefiting over 500 TB patients. Additionally, it has led cancer and sickle cell awareness campaigns through community engagement and media outreach, reaching more than 5,000 individuals. In March 2004, the Foundation organized a cancer awareness camp that hosted at least 5,000 participants in one sitting and reached over 8 million people through media campaigns.

In the education sector, the Kabaka Foundation pioneered the Kabaka Foundation Academy, which currently sponsors 60 children and youth selected from slum areas in Kampala. The academy offers vocational and life skills training to empower its beneficiaries.

The Foundation has also implemented a Water, Sanitation, and Hygiene (WASH) program, leading to the construction of 8 community toilets and the establishment of WASH facilities in 9 market areas across Kampala. These include Nakulabye, Mulago, Katwe, Nateete, Mengo, Kireka, Lubiri, Mutungo, and Bwaise—significantly promoting better hygiene

and health practices.

In the area of tourism, the Foundation promotes cultural exploration through the Kabaka's Trail, an initiative that operates with the involvement of a local committee composed of cultural leaders from the Buganda region. This committee meets monthly to preserve cultural heritage sites and promote cultural tourism.

In partnership with Buganda's traditional leaders (Abataka), the Foundation has also carried out various philanthropic projects aimed at enhancing livelihoods through moral and economic development initiatives.

In agriculture, the Foundation is partnering with Heifer International under the DREEM (Distributable Renewable Energy Eco-systems Model) Hub Project to establish a solar-powered demonstration farm in Bukalango, Wakiso District. This model farm features solar-powered technology and will serve as a center for learning and innovation. The project aims to benefit up to 500,000 people by promoting clean farming methods to improve agricultural production and increase household incomes.

Tubeele *balamu*

Extending Health Services to Communities Across Buganda
The “Tubeere Balamu” Health Campaign translated “Let’s stay healthy,” is an initiative of the Kabaka Foundation, designed to promote community health through two-day health camps across all 18 counties of Buganda. Officially launched by the Kabaka on October 30th, 2024 at Bulange Mengo, the campaign was inspired by the overwhelming need identified during a cancer awareness camp held earlier on February 2nd, 2024.

Recognizing the urgent gaps in prevention, early detection, and treatment within communities, the Kabaka Foundation initiated Tubeere Balamu as an ongoing platform to deliver free accessible medical services, facilitate timely referrals, and provide life-saving health education — especially to underserved and un-served populations. The Tubeere Balamu

camps have also played a significant role in mobilizing blood donors across the country. Building on this success, the Kabaka Foundation launched a three-year blood donation sensitization strategy (2024–2026) through the Tubeere Balamu health campaign, in partnership with the Ministry of Health, Uganda Blood Transfusion Services, and the Uganda Red Cross Society. The goal is to recruit at least 300,000 new blood donors during this period. This target will contribute significantly toward helping the Government of Uganda meet the World Health Organization (WHO) recommendation of 450,000 annual blood donors, equivalent to 1% of the national population.

Since its launch, the Tubeere Balamu Health Campaign has:

- Mobilized a strong network of upto 400 dedicated health workers from 80 health institutions, who deliver health services to thousands in the camps.

- Secured a range of essential medicines, including highly specialized drugs, which have been dispensed to patients following professional

prescriptions.

So far, three successful health camps have been conducted in the counties of Buddu, Busiro, and Ssinga, and Kyaddondo each held for two days. The fifth camp is scheduled to take place in Kyagwe on May 6th and 7th and 18th July, 2025, with the remaining counties to follow according to the campaign's work plan.

Call for Support

While the campaign has made remarkable strides, some key challenges persist:

- An overwhelming patient turnout at certain specialist centers, such as for prostate cancer screening, orthopedic services, physiotherapy, and cervical cancer screening has strained resources.
- Limited financial contributions, as most partners have supported in-kind, restricting flexibility in addressing urgent logistical and medical needs.
- Shortage of specialist doctors in fields such as pulmonology and rheumatology, leaving some patients underserved.
- Shortfall in the supply of essential drugs, especially for neurological, rheumatological, and urological conditions.

In light of these gaps, we are appealing to our partners, stakeholders, and the broader health community for strengthened collaboration and targeted support — particularly in the areas of specialist staffing, medical supplies, and financial contributions.

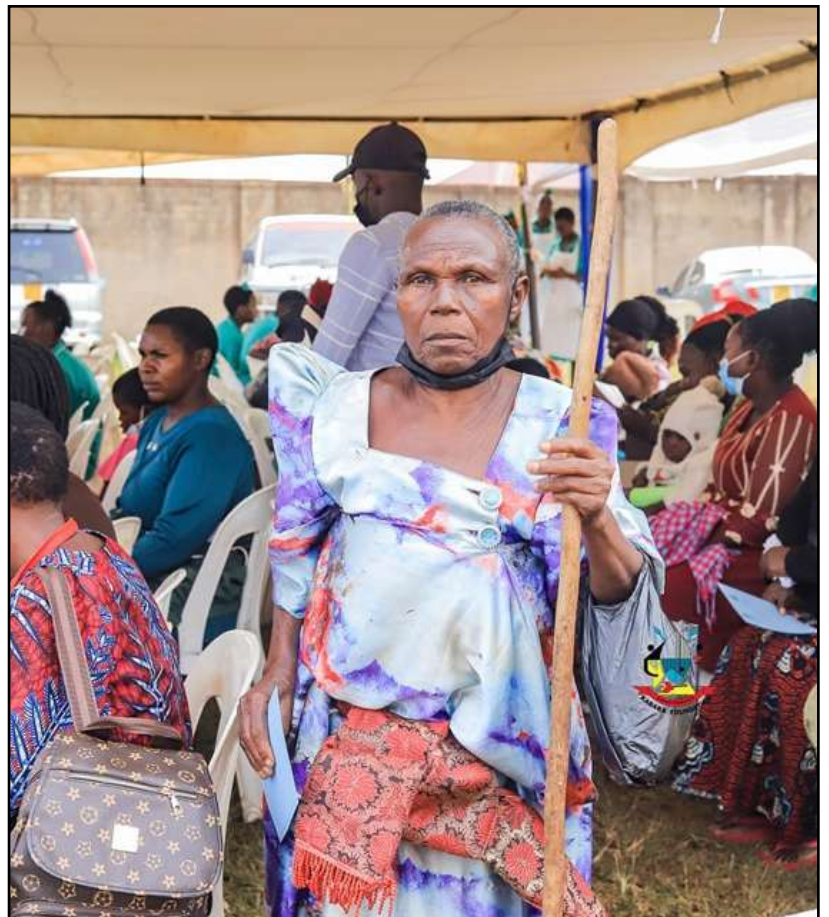

Omugottekko Program:

OBULAMU BWEBUGAGA

The Omugottekko (slum) Programme aims to empower underprivileged young people aged 5 to 25 - both boys and girls - through personal development, and economic empowerment, and the promotion of their active involvement in community development processes.

Under this initiative, the Kabaka Foundation is committed to uplifting the livelihoods of disadvantaged youth in slum communities. By 2029, the programme aspires to provide holistic support through targeted initiatives, enabling youth to actively participate in transforming their communities within Kampala City.

Mugottekko communities face numerous challenges, including poor living and health conditions. The Omugottekko Programme is addressing these issues by promoting and sensitizing people about healthcare services, aiming to enhance the overall provision and access to health within these areas. As part of this effort, the Kabaka Foundation has constructed public toilets in the slums and market areas of Kampala City to improve sanitation and hygiene.

As part of the Omugottekko Programme is the Kabaka Foundation Academy, which provides vocational training to slum-based children and youth. Tucked away in the heart of Kampala's busy cityscape, the Academy is quietly rewriting the future for some of Uganda's most vulnerable young people. The academy currently supports 60 children and youth aged 5 to 18, selected from some of the most underserved communities in the city.

These children are no strangers to hardship. Orphaned or born into extreme poverty, many shoulder adult responsibilities; becoming breadwinners by collecting scrap or plastic bottles to earn money. Without support, many face serious risks, with some being drawn into unsafe and harmful activities in their struggle to survive.

The Kabaka Foundation Academy exists to change that story. Through hands-on training in tailoring, arts

and crafts, mechanics, shoemaking, hairdressing, welding, and carpentry, the Academy empowers learners with practical skills that lead to dignified and sustainable livelihoods.

Support for these children is made possible by the generosity of individuals and Kabaka Foundation chapters across the globe. Of the 60 children enrolled, 10 are currently sponsored through the UK and Ireland Chapter, while the rest are supported by partners and friends from other chapters.

There is still room and a great need for more partners to join this life-changing journey. Sponsoring a child through the Academy is more than an act of charity; it is an investment in potential, resilience, and Uganda's future. Kabaka's trail

Domestic tourism

The “Kabaka’s Trail” is a cultural tourism program under the Kabaka Foundation dedicated to promoting and preserving Buganda’s rich cultural heritage. This trail offers a captivating journey through Buganda’s vibrant past and living traditions, shaped by the Kingdom’s kings and their descendants. It provides visitors with a unique opportunity to explore authentic heritage through food, dance, music, storytelling, traditional herbal medicine, and museums.

The Kabaka’s Trail comprises seven cultural heritage sites that are directly managed by the Kabaka Foundation, all conveniently located within easy reach of Kampala, the capital city of Uganda. The Buganda Kingdom has existed for over 700 years and has had 36 kings since its inception.

THE TRAIL SITES

1. Naggalabi – Buddo

This historic site on Buddo Hill is where Kabaka Ronald Mu-

wenda Mutebi II was crowned on July 31, 1993, in a grand ceremony attended by tens of thousands. Buddo is named after a warrior who defeated Bemba and became Ssemanobe, the guardian of the battlefield. Naggalabi has been the coronation site for Buganda’s kings for over 800 years. Spanning more than 300 acres, it offers panoramic views and features significant landmarks such as Nakibuuka, where Bemba fell, and Buganda House, where newly crowned kings retreat for nine days. Visitors can enjoy guided tours, storytelling, and traditional music performances.

2. Kanyange Cultural Centre

Overlooking Wamala Tombs, this site commemorates Nnamasole Kanyange, mother of Kabaka Suuna II, who co-ruled with her son. She played a pivotal role during the time Buganda first welcomed foreign visitors. Artifacts from 1840–1869 are preserved here, including drums gifted to her by Suuna II. Visitors can walk the historical path to Wamala Tombs, retracing the steps of Kanyange and Suuna. The site is a

30-minute drive from Kampala along Bombo Road.

3. Katereke Prison Ditch

This serene yet haunting site marks the location where King Kalema imprisoned 39 royal family members he saw as threats. Kalema's reign, during Kabaka Mwanga II's tumultuous era, was rife with intrigue and conflict. The site is located approximately 40 minutes from Kampala along Masaka Road, with access via Nsangi Town.

4. Wamala Tombs

Located in Nabweru Sub-county, these tombs are the final resting place of Ssekabaka Suuna II, Buganda's 29th king, known for introducing Islam to Uganda and initiating the construction of Kasubi Tombs. The grass-thatched tomb structure, traditional artifacts, and serene environment provide a glimpse into Suuna's legacy. It is a 30-minute drive from Kampala, near Nansana Town.

5. Sezibwa Falls

Derived from the Luganda phrase "Sizibirwa Kkubo" meaning

"my path cannot be blocked," Sezibwa Falls is both a natural wonder and a cultural site. According to folklore, it was "born" of a woman en route to Kavuma Bukunja. The site offers rock climbing, bird watching, and scenic beauty, along with traditional music and dance. It lies about 20 miles east of Kampala along the Kampala-Jinja Highway.

6. Kiryanongo Tourism Site

Known as Ekigango (meaning "courtroom"), this historic training ground for future leaders saw Kabaka Edward Mutesa II send his young son, Kabaka Ronald Muwenda Mutebi II, for early leadership grooming. Located in Ntwetwe Village, the site now serves as a tourist center and leadership training ground, with plans for a fully equipped facility that can accommodate up to 2,000 young leaders.

7. Nnamasole Baagalayaze Tombs

These tombs honor Baagalayaze, mother of Kabaka Mwanga II, who passed away in 1916. A wife of Muteesa I, she held great influence in the royal court. Today, the tombs serve as a cultural center with traditional performances, arts, and storytelling. The site is accessible via Gayaza Road, about a 30-minute drive from Kampala.

Renewable energy in agriculture

The Distributable Renewable Energy Eco-system Model (DREEM) Hub Project - Shaping a Sustainable Agricultural Future for Buganda

Access to clean and affordable energy remains a major challenge for many local farmers across Buganda. Despite the proven benefits of solar energy in powering critical agricultural processes, its adoption has been slowed by limited awareness, inadequate advocacy, and the high initial cost of equipment. These barriers continue to hinder agricultural productivity, food security, and rural development.

To address this gap, the Kabaka Foundation, in partnership with Heifer International Uganda and with support from the Charles Stewart MOTT Foundation, is implementing the Distributable Renewable Energy Eco-system Model (DREEM) Hub Project - a three-year initiative (2024–2026)

aimed at promoting smart agriculture and sustainable development. The project is advancing the Productive Use of Solar Energy (PUSE) in the agricultural value chain across Buganda by demonstrating practical applications, building local capacity, and creating access pathways that will outlive the project period.

On October 15th, 2024, the Vice President of the MOTT Foundation, Mr. Neal Hegarty, visited the Kabaka Foundation headquarters at Bulange Mengo, where he witnessed the signing of a Memorandum of Understanding (MoU) between the Kabaka Foundation and Heifer International Uganda. This partnership strengthens efforts to advance community development through the DREEM Hub initiative.

A key feature of the DREEM Hub Project is the establishment of a model farm in Bukalango village, Wakiso District. Situated on 2.3 acres of land,

the farm is to serve as a learning and innovation center (practical hub) for farmers. The farm is to showcase solar-powered technologies in agriculture - aimed at reducing costs, minimizing post-harvest losses, and increasing yields for smallholder farmers. The model farm will also demonstrate diversified horticulture, including bananas, legumes, grains, coffee, and vegetables. The project aims to engage upto 500,000 people across all 18 counties of Buganda inclusive of farmers, local technicians and other stake holders.

On January 8th, 2025, the DREEM Hub Project was officially launched by the Kabaka during an inception meeting held at the Buganda Heritage Tourism Board conference hall. The event brought together farmers, county chiefs, and agricultural leaders - to discuss implementation strategies and align on the rollout of solar-powered farming across Buganda.

Major accomplishments on the farm include the installation of a solar-powered water supply system, irrigation systems, and land preparation for horticulture. The Kabaka Foundation is also actively conducting community sensitization to help farmers understand the benefits of solar technology, access funding opportunities, and organize into sustainable cooperatives and SACCOs. Peer

learning, policy influence, and public dialogues are also being used to strengthen community buy-in.

To date, over 1,000 farmers have been engaged through awareness sessions and farm visits. In addition, Kabaka Foundation staff received specialized training at the Joint Energy and Environment Projects (JEEP) on integrating solar energy into agricultural value chains. The Foundation has also participated in both national level dialogues to advocate for broader adoption of renewable energy in agriculture.

Community engagement has highlighted a strong demand for both technical and financial support. Farmers are eager to adopt solar-powered solutions, but the cost of equipment remains a major obstacle. There is also increased recognition of the role of cooperatives in securing financing and the need for strong partnerships with NGOs, government agencies, and financial institutions. Changing perceptions, especially among the youth, is another critical focus. The sensitization meetings also aim rebrand agriculture as a modern, innovative, and rewarding career path.

The next phase of the project will include:

- Installation of a solar-powered cold storage
